

Seminar conditions

Registration

A contract on participation in a called seminar event comes about by filling and sending the registration form to us in writing or electronically form on the part of the customer (PDF by e-mail, fax). Registrations are obliging. In case of the overbooking the announcing is immediately informed. At short notice the registration is booked on receipt of taking into account free seminar places. After the registration you receive from us a registration confirmation by e-mail or by post.

Participation fee

The participation fees for the seminars please take from the respective seminar side. The prices get on per person. The seminar prices that are valid on the day of the order are binding. The seminar price becomes due in general before the beginning of the seminar and must become immediately pay.

Seminar refusal

We are entitled to withdraw at short notice from the contract, provided that up to this time an insufficient number of participants has announced itself for the talk. If the participant has already paid fees to us, these are refunded for him by paid height. Further claims of the participant are excluded.

Change in the supporting programme

Our talks are planned in the long term and, hence, it can come in special cases for changes of venues and appointments or the advisers (case of illness) whom we must reserve ourselves. We inform the participant about the transfer or the refusal. Further claims of the participant are excluded.

Cancellation terms

Because the seminar places cannot be posttaken at short notice, we calculate from 2 weeks before the seminar beginning the following cancellation fee: With the written resignation which reaches us at the latest on the 15th day before the seminar appointment we refund the full seminar price. Then becomes up to the 5th day before the seminar 50% of the seminar price, afterwards the full price raised. The cancellation needs the written form. You can transfer your participation authorisation any time on a spare part taker in writing to be named by you. With refusal of the seminar by the organizer for organizational reasons or as a result of higher power (e.g., illness of the adviser) the seminar price is refunded. For vain expenditures or other disadvantages which originate to the customer from the refusal the organizer does not arise.

Data protection

Your data are stored for the internal subsequent treatment and own advertising purposes by us under strict observance of the data protection act of the Federal Republic of Germany. As the case may be we transmit addresses to the enterprises whose offer for you concerning contents, quality and service could be interesting.

Liability

From the use of acquired specialist knowledge no liability claims can be asserted towards us. The organizer does not stick for the loss, the damage or the setting of things of the participant in connection with the realisation of the seminar, as far as this is not to be led back on deliberate or roughly careless behaviour of us. We do not stick for damages which are not to be led back by higher power, turmoil, war events and natural phenomena as well as other, from him to incidents to be represented (e.g., strike, lockout, traffic block, possession in and foreign state places) or on not culpably caused, technical disturbances, possibly of the EDP system. For reservation costs or journey costs which originate to the participant in case of a refusal of the seminar from us no liability can be also assumed.
